MAJOR ACCOMPLISHMENTS

🌟 CERTIFICATES OF INSURANCE

Passed legislation to prevent parties from requiring agents to put incorrect or misleading information in certificates of insurance.

🌟 WORKERS' COMP OPT-OUT

Successfully defeated opt-out legislation that would have allowed employers to not provide workers' compensation coverage.

🌟 ASSOCIATION MEMBERSHIP CE

Advocated for adoption of a TDCI rule that provides Insurors members two continuing education credit hours a year.

🌟 REFERRAL FEES

Passed legislation to ensure that agents can adequately compensate employees & individuals they are in business with.

🌟 AGENT BILL OF RIGHTS

Required TDCI to provide notice to agents if they are under investigation and to close pending investigations within two years.

🌟 DUTY TO READ

Protected agents by creating a presumption that an insured accepts the coverage provided by paying the premium.
